In 2017 the Combat Wounded Coalition provided over 500 opportunities to highlight, recognize and support combat wounded warriors. We sent approximately 200 clothing kits to wounded verterans. We raised national awareness of the sacrifice our wounded warriors are making. We supported wounded warriors through empowering events such as jumping for a purpose (skydiving). We connected wounded warriors to educational and other opportunities. Lastly, we saved over \$700,000 through volunteer services and continued partnerships with other vetted wounded warrior vereran organizations.
